

Accounting Course Number: 22:010:603 Course Title: Income Taxation

COURSE DESCRIPTION

This course is designed for tax students to explore the fundamental principles and concepts of federal income taxation. This includes identifying income, determining if the income is included or excluded from taxation, understanding the timing of income recognition as well as the character of income. Students will also study tax deductions understanding what is allowable as well as the timing of when the deduction may be claimed on an income tax return. Students will also study the taxation of property transactions, including sales and other dispositions.

The course format will include lectures, discussions, and some group problem solving. There will be a heavy emphasis of studying the Internal Revenue Code and other primary sources of tax law (Regulations Court Cases, etc.). This will be reinforced through class lectures, and solving homework problems related to each lesson, enabling the tax student to apply and understand the materials covered in this course.
