### COURSE DESCRIPTION

The United States Taxation of International Transactions is the most dynamic area in the field of Federal Income Taxation. It is also one of the most complex areas of U.S. Taxation. This course is an in depth study of "outbound" transactions-Subpart F and the Foreign Tax Credit. A student who completes the course will gain a strong understanding of the principles, issues and planning concerning the U.S. Taxation of Foreign Transaction. This is an important course to complete your tax knowledge.

Students will learn how to integrated the Internal Revenue Code, Treasury Regulations, IRS Pronouncements and Case Law regarding the subject matters taught in the course. The student will develop analytical skills on how to identify and resolve complex Federal International tax issues of "outbound" transactions.
