

Finance Course Number: 29:390:331 Course Title: Ethics in Finance

COURSE DESCRIPTION

This course focuses on the ethical issues confronting financial professionals, including extensive coverage of the recent financial crisis, major corporate violations and the very latest developments affecting ethics within the financial world. Instruction includes an overview of the ethical standards in finance, including the primary elements necessary to make proper ethical decisions. The course also covers key definitions, issues, and general theories of business and finance ethics, citing examples of famous corporate and investment management fraud cases and from the recent scandals that have shaken public confidence in Wall Street and the world financial markets. Students leave the course with a better overall understanding of ethical issues confronting financial professionals and how to apply ethical behavior in everyday business practices.

COURSE MATERIALS

- A. There will <u>not</u> be any required textbook for this class. I will be using-John R. Boatright, *Ethics in Finance*, third edition.
- B. Required reading, Liar's Poker, Michael Lewis
- C. Papers/Articles identified in class (mentioned as homework assignments)

COURSE OUTCOMES

After successful completion of this course the student will:

- Understand the definition of ethics and the importance of ethics in Finance
- Recognize the roles and responsibilities of individuals, corporations, and government regulators on ethics
- Understand concepts associated with business ethics and the impact of business ethics on corporate governance and investment management
- Have a heighten awareness of ethical issues and commitment to norms and values in the area of finance (recognize conflicts of interest, understand fiduciary duty and be able to discuss ethical dilemmas and unethical behaviors.
- Increase skills, knowledge and attitudes that will help with resolution of ethical situations or problems in an appropriate manner

Understand how firms and industry organizations develop codes of conduct and the impact such
codes have on a variety of financial industry activity including corporate governance, member
behavior and stakeholder outcomes.

METHOD OF INSTRUCTION

- A. Lectures (notes will be made available the night after the class)
- B. Homework- Each student is to read the assignments for each week. Assigned homework reading and analysis explicitly described in class Syllabus and announced in class must be typed and submitted by the due date and time according to the instructions provided.
- C. Class participation (and discussion) is very important in this course where many of the situations which we will examine do not have clear-cut "right or wrong" answers. Your answer may often depend on your background, both spiritually and culturally. Therefore, class participation is essential to enhance your understanding of ethics and their impact on business and particularly in Finance (Corporate and Investment Management). Students will be assessed on class participation and graded on the quality of their answers.
