LEARNING GOALS AND OBJECTIVES

This course will examine the history of money and banking and then will progress into the modern era where there have been significant changes made in the operations of financial institutions. At the same time, markets will be discussed examining their role in the use of money and the expansion of banking as an essential function in modern economies.

The course will not delve too deeply in economic theory as that is best left to the paired courses on macro and micro economics.

PREREQUISITES

I am happy to have anyone take this course. However, those students with a prior knowledge of accounting, finance, and economics, will find that knowledge very helpful during the course of the semester.

Obviously, prior banking knowledge and experience will be extremely useful to the student.

TERM PAPER DESCRIPTION

There is a term paper that is an important part of your grade. This work is to be accomplished individually.

The term paper is based solely on The Merchant of Venice (MOV) and any classroom discussion that pertains to this play.

WRITTEN OBLIGATION:

Looking beyond Shakespeare's social commentary, which is focused on life in England almost 600 years ago, there are many elements of this play that contain lessons about banking, lending and risk that apply to modern times.

In no less than two and no more than five pages (single spaced, 12 pica type), please discuss the errors that Bassanio made in MOV from the perspective of good banking practices and compare his actions to those of the financial institutions that were major players in the 2007-2009 meltdown in the U.S. economy that has resulted in so many changes. And finally, discuss those changes, at least in part, touching on the major issues.

Your grade on this paper will be based on all aspects of the submission, including your analysis of Bassanio, comparison of his actions to that of modern banks during the crisis and the quality of the writing, including grammar, punctuation, etc.
