

Finance Course Number: 29:390:494 Course Title: Pension Fund Management

COURSE DESCRIPTION

The course describes and analyzes the different retirement vehicles provided by business for employees. In particular, the course describes and analyzes in detail the major differences in defined benefit and defined contribution plans, including the tax aspects. Topics also include paths for personal retirements and the social security program.
